This is a contract between White Rose Boarding Kennels (hereinafter called "The Kennels") & the pet owner/s or owners/s agent whose name and signature appears below ( herein called " The Owner ")

- 1, I have read the opening hours and agree to pick up or drop off pets during those hours and will arrive promptly before closing time. Our hours are displayed at the front gate, our inner security gate, in the office and on our web site. ( Please observe them & respect them ).
- 2, Boarding rates are displayed in reception and on our web site, the boarding rate is charged per day this counts the day of arrival and departure regardless of whether you drop off or pick up in the morning or afternoon.
- 3, I acknowledge there are no refunds for early pick ups and that all kenneling fees are to be paid in full before removal of the pets.
- 4, Owners warrant that that all pets have been vaccinated to level C5 and are healthy and free of all infectious diseases, ticks or fleas.
- 5, Owners give full authority to the kennels to call a veterinary surgeon for any treatment, procedure or to gather or exchange information of the pets in the event of sickness, illness, accident or any reason should the kennel deem necessary at the owners expense and agree to pay all expenses prior to removal of the pet/s.
- 6, I authorize that my dog/s may be kenneled, play & socialize with other dog/s of similar size, temperament & nature.
- 7, If the dog is not collected 14 days after the contracted collection date & the kennel as had no notification from the owners , the dog will be disposed of at the kennels discretion..
- 8, All reasonable care and attention is given and pets are accepted at the owners risk upon these terms and conditions . White Rose Boarding Kennels it's staff & or agents do not accept responsibility for sickness, illness, accident, escape, injury or passing away of pets for any reason.
- 9,The kennel is not responsible loss or destruction of toys, leads, collars, council tags, or bedding
- 10, I accept that the kennel reserves the right to refuse entry.
